

Water Quality Plan

- Water testing-chemical and clarity
 - Secchi Readings weekly/biweekly at 10+sites
 - MPCA testing-done 2015 and 2016 5 times at 5 sites
 - Updated WCOLA Water Quality plan is in place
 - Emulate MPCA closely in protocol, sites, frequency each month for 5 months ice out through fall
 - WCOLA testing-two years mid MPCA testing at 7 sites
 - RMB Water Quality Reports on each lake complete
