# Lake Safety, Education, & Etiquette

The goal of these memos is to help keep everyone safe while, at the same time, maximizing the enjoyment of the lake for as many as possible in a positive manner. We are all blessed to be able to spend time on the Wabana Chain of Lakes. Let's all be safe and good neighbors at the same time.

#### Overall Safety/Education/Etiquette:

- Please wear a Life Jacket. For adults: Lifejackets are to be 'readily available', including a throwable floatation device on boats 16'+ feet. For the children: Any child under 10 years old or younger must have a life vest on while underway. Please be safe and take care of the little ones. This applies to all watercraft from boats to PWCs to pontoons to non-motorized crafts.
- Please Don't Drink and Boat Alcohol and boats don't mix. MN laws are the same as driving an automobile. Please be safe.

#### **Boat Specific:**

- When 'at speed' try to stay 150+ feet from shore whenever possible (larger wakes +200 feet).
- Reduce repeated passes on the same shoreline when possible. At times, weather will make this a challenge. Be reasonable with the amount of time in the same location.
- Wake boats can be hazardous when operated in constricted waters or near other water craft. Wake boats need to be kept well away from both shoreline & other water craft.
- Skiing, wakeboarding, tubing, etc. are allowed between sunrise and ½ hour after sunset.

#### PWC (Jet Ski):

- When 'at speed' (above 5 MPH) please stay 150+' from shore, other watercraft, swimmers, etc.
- Watch your speed boats, people, land, docks, other PWC's come up quickly and jet skis do not have brakes.
- As much as we love our children, know that they act differently when they are out of our sight. Have a serious conversation both on the safety and etiquette of Jet Ski use. These machines are powerful and a ride can go from fun to the opposite in a matter of seconds.

#### Pontoon:

Pontoons are some of the safest boats on the water. A few tips to make them even safer:

- Be cognizant of the capacity of your pontoon. There should be a sticker with the maximum number of people and/or maximum weight. Spread out the weight of passengers evenly when out for a cruise. A few too many people in the front can lead to waves coming over the bow.
- Keep everyone inside of the pontoon. While it's appealing to sit on the front and dangle your legs in the water, it's very dangerous if someone were to fall off and go under the pontoon.

#### Non-Motorized Watercraft (Canoe, Kayak, Paddle Boards, etc.):

- The safest place for these watercraft is near the shore, especially during busy lake times.
- There have been a few of these watercraft out well past dark with no lights. This is very dangerous as they are nearly invisible. If out past sunset, please have a light kit.

**Protect our Lake:** For boats coming from outside Wabana lakes please follow the guidelines below. We have a great team checking boats at the landing but every one of us can do our part.

- **CLEAN** Clean any boat, trailer or water related equipment. This is a MN Law which helps to protect our lake from aquatic invasive species. Talk to your friends and family before they arrive with their boats.
- **DRAIN** Remove drain plugs and keep them out while transporting from all waterrelated equipment: ballast tanks, portable bait containers, motors, drain bilge, live well, and bait well.

## Wabana Township Comprehensive Use Plan Update

Wabana Township is developing a Comprehensive Plan, utilizing a group of the township's volunteers, to provide:

- 1) A history of where the township came from and a resource outlining all that it has to offer today,
- 2) A road map and a vision for the future of Wabana Township as an integral, valuable component of Itasca County providing recreational opportunities and offering a mix of rural residential living under a pristine environment, and
- 3) The basis of the township's operations and a pathway for future decisions as well as a basis for dealing with all Wabana stakeholders.

It is Wabana Township's goal that it will be a fully intact, rural part of Itasca County as a whole, whose rural qualities will vary as appropriate within the Township and whose central physical feature is the clean and attractive waters of the lakes.

The purpose of the plan is to define, with community inputs:

- The desires to retain and promote a sense of community,
- The future uses of the land within the township, large land tracks, shoreland areas,
- The plans for future management of the roads of the township,
- The plans for future development and current management of recreational assets,
- The plans for preserving and protecting our natural resources,
- The needs for maintaining and improving the township facilities,
- Shore land overlay guidelines that would best work with the mission of protecting the water quality both from a recreational and economic standpoint for all Wabana Township lakes,
- Currently Wabana Township has an ordinance (Ord. 101), originally adopted in May 2003, that regulates the subdivision and development of land within the Shoreland Overlay District within Wabana Township, this will be reviewed based on citizen inputs.

- Strengthen the relationship and collaborate with the Wabana Chain of Lakes Association (WCOLA),
- Develop and strengthen Wabana Township's working relationship and collaboration with the Itasca County Board of Commissioners, Environmental Services Department and land departments (MN DNR, MPCA, various Soil and Water organizations).

For the development of this plan, the goal of the committee is to keep the plan's development costs minimal through volunteer efforts, in-kind services, and other low- cost support. Professional support will be utilized to facilitate the community meetings for citizen inputs, final packaging, and distribution of the plan. Itasca County has offered copy & printing at cost, and other county departments services. Township legal services will 1) review, comment, and update the comprehensive plan's wording as needed, and 2) address and update the Township's Shoreland ordinance (Ordinance 101) to reflect citizen inputs obtained by the Comprehensive Plan effort.

Funding for this effort will be primarily from the Township's reserve funds, a grant of \$9,000 from Iron Range Resources & Rehabilitation Board (IRRRB) and WCOLA. If you are interested in supporting this effort financially, you may make a donation to WCOLA.

All Township residents and property owners will be receiving an on-line survey asking for their inputs to a variety of questions, this will be followed-up with two community meetings to gain further inputs, thoughts, concerns. Please take the survey and attend the meetings so your voice can be heard. Notifications and availability of the survey will be in May, 2020, with community meetings planned for this summer (pending Covaid-19 guidelines).
