#### **AIS Inspectors Primer**

WCOLA has two accounts used for support of AIS inspectors at the Wabana boat landings and at the Wabana Township Decontamination station.

For the boat landings inspectors, \$5,000 is budgeted as part of the annual WCOLA budget for which annual dues and donations pay for. The \$5,000 along with \$2,500 from Wabana Township is then combined with matching CAP grants that yield a total of \$15,000 per boat inspection season (mid-May through early October). The \$15,000 provides enough for 25 hours of coverage per week of one inspector at one landing (50 hours per week for 2 landings). The County then provides 15 additional hours of inspector coverage per Wabana boat landing. This results in 40 hours of inspector coverage per week.

How many boats use the landings per week and would be covered when inspectors are available Friday -> Monday you ask? WCOLA has one car counter that alternates between landings and count data indicates that approximately 75% of the boats access the lake Friday thru Monday. The landing averages are:

South Landing: 73 boats per week (53 Friday to Monday ) North landing : 154 boats per week (117 Friday to Monday)

# AIS Inspectors Coverage- a primer (continued)

As for the Wabana Station Decontamination unit, this is the first year of its operation. There has been an increase in boat washes as the "word gets out". This station was staffed Friday, Saturday, and Sunday through the end of August and less hours and days in September as inspector resources became limited. The site is staffed with a Level 2 AIS inspector (trained to do boat washes and inspections). There were 22 washes performed the first two months of operation, six of which required a thorough decontamination. Funding for inspectors of the Decon unit is paid for from the fund-raising dollars raised in 2020-2021, and is sufficient to cover operations for the next two years. The Decon station not only benefits the Wabana Chain of Lakes but all the surrounding lakes.

To continue or increase funding for AIS inspectors both at the landings and the boat wash, we are looking for ways to raise additional funds without increasing annual dues significantly. As mentioned in the "President's Reveries", we will be offering a deck of cards and starting a WCOLA on-line store to help raise additional funds. Your support for purchase of these items will be greatly appreciated.

Next January when the annual membership renewal comes out, it will also ask if you would like to make an additional donation for AIS efforts above your annual due amount. Over the last few years, generous amounts have been donated and used for AIS inspection support.

There are many lakes in Itasca County and throughout Minnesota with AIS and many boats from those lakes use the Wabana Chain for recreation. Helping to prevent the spread of AIS is a primary focus of WCOLA and have landing inspectors and providing boat washes are means to prevent the spread.




























