### Fall 2023

The WCOLA sponsored boat wash that has been located at Wabana Township Hall is being moved to the NW boat landing for next year. WCOLA needs your help! My term as president ended at the annual meeting back in August. Though there were emails sent out and articles in the newsletter asking if anyone was interested in the position of president, nobody has volunteered. I will finish this calendar year as president, but WCOLA needs an individual to assume the position of president starting January 2024.

# WCOLA AIS INSPECTION SEASON ENDING STATISTICS:

\* 1,437 Inspector man hours. All CAP Grant hours were met.

600 baseline hours (300 per landing) + 600 CAP grant hours = 1,200 hours.

- \* 639.5 Wabana SE
- \* 797.5 Wabana NW
- \* 2,348 inspections = 1.63 inspections per hour. This ranks the Wabana

NW landing 8th, and Wabana SE 10th busiest landings out of 24 landings where we were stationed. Wabana SE had 1,011 inspections and Wabana NW had 1,337 inspections.

\* 2,348 inspections

- \* 1,400 incoming inspections.
- \* 100 incoming violations intercepted. All were corrected prior to launch.
- \* 18 had come from an infested lake.
- \* Swan Lake: Curly-leaf pondweed
- \* Spider: Flowering rush

\* 2 last lake 1-4 days.

6 were plants.

 Upper Red Lake: zebra mussel, starry stonewort

1 last lake less than 24 hrs.

- \* 15 last lake 5 or more days.
- 1 had come from an infested lake less than 24 hours ago.
- \* Upper Red Lake: zebra mussel, starry stonewort



### Firewise Update for 2024:

Firewise Info from John Moore Itasca Co.

I spoke with Itasca County Land Commissioner Kory Cease and Assistant County Land Commissioner Michael Gibbons about Firewise going into the future. What they advised me to do is reach out to all of our communities and say at this time, the Itasca County Firewise program cannot commit to any future pickups. What we have been told from the State is that Itasca County is in a moderate risk for fire danger. There are other counties in the State that are a high risk fire danger, and this year the grant money was distributed to them. To me that means that the Itasca County Firewise program has accomplished its goal over the last 15 years.

Therefore, I am telling you all to not start any piles for next year. Please pass this on to all of your community members. Between now and next spring, I will keep you posted on any information regarding the future of Itasca County Firewise.

This is not necessarily a bad thing. I take it as a compliment as the fruits of our labor over the last 15 years to make our communities Firewise safe. Through the education and our labor efforts we have created an opportunity for our County to continue to be Firewise safe without this program. With the knowledge that we have all gained from the Firewise program, we can continue to keep this county safe from wildland fires.

Hopefully in the future this program will continue. If it doesn't, the education

we all gained from this will benefit us all in the future.

#### The Boat Wash at Wabana Station: An Update

After a successful launch of the self-serve boat wash in 2020, and the AIS Decontamination Unit in 2021, some changes are in store for 2024.

The plan right now is to move the Decontamination Unit to the northwest public access on Wabana Lake. This will allow the existing AIS inspector at that landing to also conduct watercraft decontaminations. This arrangement would eliminate the need to employ an inspector at Wabana Station, providing a substantial cost savings.

Since this public access is also scheduled to undergo an expansion by the DNR, the timing of this move is perfect. We are expecting to see some initial work accomplished yet this fall, with a goal of completion by Memorial Day 2024. AIS Decontaminations could then be conducted at this location for the remainder of the open water season.

The self-serve boat wash at the Wabana Town Hall will remain open 24/7 next year, unchanged from 2023.

We will plan to provide another update in the spring newsletter.

### **Guest Letter**

#### Annual WCOLA Loon Survey 2023

In 1994, the Nongame Wildlife division of the MN DNR began surveying loon populations as part of the Minnesota Loon Monitoring Program (MLMP.) There are 600 Minnesota lakes surveyed each year across six key index areas. Lakes must be at least 10 acres in size and deep enough to overwinter fish. This is a long-term project that is made possible by the assistance of hundreds of volunteers across the state. Within a period of 10 days each summer, volunteers visit their designated lake(s) one morning to conduct the survey. Almost 30 years of data has helped estimate that Minnesota has a population of roughly 12,000 loons—more than any of the lower 48 states! Historically, WCOLA member Bill Berg surveyed both Trout and Little Trout lakes for many years. We took over the Wabana survey from DNR employee Sarah Verke in 2014, and in 2022 we added both Trout and Little Trout. Blue Water is also part of the survey area, so please give us all a shout if you are the volunteer who conducts the survey! There is also an additional count that has been done later in the summer by a different group of volunteers as part of the Loon Watcher program.



Here are the results of the 2023 survey for the three lakes we were assigned:

Lake	Adults	Juveniles
Wabana	21	2
Little Trout	2	0
Trout	22	0

We were able to relocate the twins in Wabana's Birch Bay multiple times, and it is always a joy to watch them grow up before migration.

The Nongame Wildlife Program is funded only through donations and does not receive any financial support from other sources (license plate sales, fishing/hunting licenses, etc.) The continuation of programs such as MLMP require both volunteer support and financial donations. You can donate directly via the MN DNR website, or you can "look for the loon" line item on your MN tax forms. Each year the MLMP team issues an annual report discussing the health of our state's loon populations, and it can be found by visiting the MLMP section of the DNR's website. You can also reach out to me if you would like a copy of the report.

The loons are preparing to head south for winter, but we will again be waiting to count them next summer as they come home to nest.


